1. The data we collect about you

We may collect, use, store and transfer different kinds of personal data about you as follows:

We explain these categories of data here:

• Identity Data. When purchasing a product or subscribing to our newsletter the information you provide will form part of this.



- Contact Data.
 As above.
- Financial Data.

When completing a transaction with us, the information you provide through the e-commerce provider.

Transaction Data.

As above, including details of your purchase.

Technical Data.

Your internet protocol (IP) address used to connect your computer to the internet, browser type and version, time zone setting, operating system and platform.

Profile Data.

As detailed in Identity data.

Usage Data.

Information about your visit, including the uniform resource locators (URL) clickstream to, through and from our site (including data and time); products you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks and mouse-overs), and methods used to browse away from the page.

Marketing and Communications Data.

As in identity data described above.

2. How we use your personal data

We will only use your personal data for the purpose for which we collected it which include the following:

- To register you as a new customer.
- To process and deliver your order.
- To manage your relationship with us.
- To enable you to participate in a prize draw, competition or complete a survey.
- To improve our website, products/services, marketing or customer relationships.
- To recommend products or services which may be of interest to you.

3. How we share your personal data
